PLANNED GIVING is LEGACY GIVING

Planned giving provides you the opportunity to create a legacy gift, forever honoring your passion for Helping Hand Home's mission.

A *planned gift* benefitting the Home may be made in several ways including:

- Making a **bequest** in your will to the Home's Foundation
- Designating the Home's Foundation as the beneficiary or co-beneficiary of an **IRA** (or portion of IRA) or **life insurance policy** (or portion of a policy)
- Giving the **remainder interest in your home** to the Home's Foundation
- Making a **gift annuity** to the Home's Foundation

It is best to make planned gifts to "**Helping Hand Home for Children Foundation**." You may wish to take a further step and make your gift to one of the following two funds within the Foundation:

1. "**Helping Hand Home for Children Foundation Heritage Fund**"* or
2. "**Helping Hand Home for Children Foundation General Fund**"**

Donors are not required to choose one of these options, but designating a fund within the Foundation will assist the Home in honoring your wishes.

Consult an attorney for assistance with bequests and some planned gifts.

***Foundation Heritage Fund:** *The original value of your gift may be spent only if an emergency threatens the existence of Helping Hand Home. The revenue from your gift is available for distribution upon approval by the Helping Hand Home Board of Directors.*

****Foundation General Fund:** *The original value of your gift and the revenue generated from it may be spent upon approval by the Helping Hand Home Board of Directors.*

CIRCLE OF HOPE

When you make a planned gift for the benefit of the Home (or give a gift during your lifetime to the Home's Foundation) **AND** you inform the Home of this gift, you will be included in the **CIRCLE OF HOPE**.

Your thoughtful generosity may inspire others. You will be invited to an annual "thank you" reception in the fall and recognized in other ways throughout the year.

BEQUESTS

The most common planned gift is a charitable bequest, naming "**Helping Hand Home for Children Foundation**" as a beneficiary in your will or living trust. A bequest may take on a number of forms, including naming a specific dollar amount, naming a percentage of the estate, and/or naming specific assets.

Sample language to make an unrestricted gift through a bequest:

I give and bequeath (*the sum of _____ dollars*), or (*all of my estate*) or (_____ percent of the rest, residue and remainder of my estate) in cash, securities, and other property to Helping Hand Home for Children Foundation.
