*Circle of Hope* recognizes individuals who have created a planned gift by including Helping Hand Home in their long-range financial and/or estate plans. A planned gift benefiting the Home may be made in several ways including:

- Making a bequest in your will
- Designating the Home as the beneficiary or co-beneficiary of a life insurance policy or IRA
- Giving the remainder interest in your home to Helping Hand Home
- Making a gift annuity to the Home

**When you join *Circle of Hope***, Helping Hand Home will acknowledge your thoughtful generosity and your commitment may inspire others to make a planned gift. *Circle of Hope* members are invited to an annual fall "thank you" reception and recognized in other ways throughout the year.

## THE BEQUEST

The most common planned gift is a charitable bequest, naming Helping Hand Home for Children Foundation as a beneficiary in your will or living trust. A bequest may take on a number of forms, including naming a specific dollar amount, naming a percentage of the estate, and/or naming specific assets.

### **Sample language to make an unrestricted gift through a bequest:**
